BACKGROUND:

Through the Fireman's Fund Heritage Program, Fireman's Fund Insurance Company and its network of independent agent's award grants to fire departments and fire/burn prevention organizations across the country. Sihle Insurance Group identified Seminole County's Fire Station #36 as a recipient of a grant totaling \$23,482.00. The funds will be utilized to purchase approximately 20 sets of protective firefighting gear.
