BACKGROUND:

PS-1386-06/DRR was awarded by the BCC on January 23, 2007 to Burke, Hogue & Mills Associates, Inc. of Lake Mary, not to exceed \$142,650.00. The contract agreement provided for professional architectural and engineering services for a 9,000 sf, two-story building adjacent to the existing Museum of Seminole County History. The new building would have been historically compatible with the existing structure.

On July 1, 2007 at the Budget Work Session, direction was given by the BCC to terminate PS-1386-06/DRR due to budgetary constraints.

2. CONSULTANT agrees that no further payment is due under said Agreement as no services were rendered.
