BACKGROUND:

The County provides funding to the City of Casselberry through an Interlocal agreement for the city to maintain County roadways within City limits. The BCC agreed to terminate all such agreements during the May 1, 2008 Budget Consensus special session. The County currently reimburses the City of Casselberry \$13,851 annually per said agreement.

**MUTUAL TERMINATION OF INTERLOCAL AGREEMENT

SEMINOLA BOULEVARD FROM U.S. HIGHWAY 17-92 TO LAKE DRIVE**

THIS MUTUAL TERMINATION of Agreement is made and entered into this ____ day of _____, 20__, by and between the **CITY OF CASSELBERRY**, a Florida municipal corporation, whose address is 95 Triplet Lake Drive, Casselberry, Florida 32707, hereinafter referred to as "CITY", and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

W I T N E S S E T H:

WHEREAS, on February 26, 2004, the parties entered into an Agreement for landscape and irrigation maintenance on Seminola Boulevard from U.S. Highway 17-92 to Lake Drive; and

WHEREAS, the Agreement has since been deemed unnecessary; and

WHEREAS, any fees owed to the CITY pursuant to this Agreement have been paid in full,

NOW, THEREFORE,

1. CITY and COUNTY hereby agree that the Interlocal Agreement issued on February 26, 2004 is hereby terminated.

2. CITY agrees that no payment is due under said Agreement as all fees due have been fully paid by the COUNTY.
