BACKGROUND:

The County provides funding to the City of Longwood through an Interlocal agreement for the City to maintain County roadways within City limits. The BCC voted to terminate all such agreements during the May 1, 2008 Budget Consensus special session. The County currently reimburses the City of Longwood \$22,407 annually per said agreement.

THIS MUTUAL TERMINATION of Agreement is made and entered into this _____ day of _____, 20___, by and between the **CITY OF LONGWOOD**, a Florida municipal corporation, whose address is 175 W. Warren Avenue, Longwood, Florida 32750, hereinafter referred to as "CITY", and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

W I T N E S S E T H:

WHEREAS, on January 15, 2004, the parties entered into an Agreement for landscape and irrigation maintenance on County Road 427 (Ronald Reagan Boulevard) from North Street to General Hutchinson Parkway; and

WHEREAS, the Agreement has since been deemed unnecessary; and

WHEREAS, any fees owed to the CITY pursuant to this Agreement have been paid in full,

NOW, THEREFORE,

1. CITY and COUNTY hereby agree that the Interlocal Agreement issued on January 15, 2004 is hereby terminated.

2. CITY agrees that no payment is due under said Agreement as all fees due have been fully paid by the COUNTY.
