BACKGROUND:

The County provides funding to the City of Oviedo through an Interlocal agreement for the city to maintain County roadways within City limits. The BCC voted to terminate all such agreements during the May 1, 2008 special session. The County currently reimburses the City of Oviedo \$72,836 annually per said agreement.

COUNTY ROAD 419 AND COUNTY ROAD 426 WITHIN THE CITY OF OVIEDO
CORPORATE LIMITS**

THIS MUTUAL TERMINATION of Agreement is made and entered into this _____ day of _____, 20__, by and between the **CITY OF OVIEDO**, a Florida municipal corporation, whose address is 400 Alexandria Boulevard, Oviedo, Florida 32765, hereinafter referred to as "CITY", and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

W I T N E S S E T H:

WHEREAS, on July 6, 2007, the parties entered into an Agreement for right-of-way and median maintenance of County Road 419 and County Road 426 within the City of Oviedo corporate limits; and

WHEREAS, the Agreement has since been deemed unnecessary; and

WHEREAS, any fees owed to the CITY pursuant to this Agreement have been paid in full,

NOW, THEREFORE,

1. CITY and COUNTY hereby agree that the Interlocal Agreement issued on July 6, 2007 is hereby terminated.

2. CITY agrees that no payment is due under said Agreement as all fees due have been fully paid by the COUNTY.
