BACKGROUND:

The Florida Department of Environmental Protection (FDEP) offers the FRDAP grant program to financially assist local governments with improving land for public outdoor recreational use. On May 8, 2007, the Board of County Commissioners approved submission of an application for use at the Jetta Point Park, and staff received notification that Seminole County was awarded \$135,611. There is a 50% cash match requirement which will be met from existing project funds which bring the total expendable amount to \$271,222.

The grant approval is presented separately on this meeting's Consent Agenda.

Staff recommends that the Board approve and authorize the Chairman to execute a Resolution implementing Budget Amendment Request (BAR) #08-93 through the FRDAP Grant Fund in the amount of \$135,611.00 to allocate funding for Jetta Point Park.
